Proyek Listrik Panas Bumi Sarulla Mencapai Operasi Komersial Penuh *Sarulla Geothermal Power Project Achieves Full Commercial Operation*

Jakarta - Sarulla Operations Limited (SOL) akhirnya telah mencapai status operasi komersial penuh dari 3 x 110MW Proyek Pembangkit Listrik Tenaga Panas Bumi, setelah operasi komersial pembangkit ketiganya pada 4 Mei 2018. Sebelum Penyelesaian Unit-3 ini di lapangan Namora-I-Langit, SOL memulai operasi komersial Unit-1 di Silangkitang dan Unit-2 di Namora-I-Langit masing-masing pada Maret 2017 dan Oktober 2017.

Penyelesaian yang berhasil dari unit ketiga ini menandai pencapaian besar proyek geotermal terbesar dalam satu kontrak.

“Kami sangat bangga dapat melaksanakan proyek geothermal 330MW dengan sukses, memenuhi komitmen kami kepada Pemerintah Indonesia dan memberikan kontribusi pada tujuan strategis nasional untuk menyediakan listrik dari energi terbarukan,” Ucap Shinichi Aburaya, Kepala Eksekutif Sarulla Operations Ltd.

Jakarta – *Sarulla Operations Limited (SOL) has finally achieved its full commercial operation status of its 3 x 110MW Geothermal Power Project, following the commercial operation of its third plant on May 4, 2018. Prior to this Unit-3 completion at Namora-I-Langit field, SOL started commercial operations of its Unit-1 in Silangkitang field and Unit-2 in Namora-I-Langit field in March 2017 and October 2017 respectively.*

This successful completion of the third unit marks the great achievement of the largest geothermal project under a single contract.

“We are very proud of delivering the 330MW geothermal project successfully, fulfilling our commitment to the Government of Indonesia and contributing to the national strategic objective of providing electricity from renewable energy”, said Shinichi Aburaya, Chief Executive of Sarulla Operations Ltd.
